BRT offers eight-week sessions of **Absolute Beginner Ballet** classes that provide interested adults with a fun and informative introduction to proper technique. This program is developed for beginning adult dancers with no previous experience or the student who wants to refine their technique at a basic level and focuses on the basic movements and foundations of ballet technique. If you have never studied ballet but always wanted to, this is the class for you.

Payment Policies

TUITION IS NOT REFUNDABLE. Students who miss class or withdraw before the end of the Absolute Beginner Ballet 8-week session are still obligated for the full session's tuition. Credit cannot be given for missed classes. Students are eligible for pro-rated tuition refund only if they withdraw from classes due to a prolonged illness or severe injury, and if verified by a doctor's certificate.

CANCELLATION. If you intend on withdrawing from class, then you must notify BRT in writing one week prior to the start of the session. If written notice has not been received by a week prior to the start of the session, the student will still be considered enrolled and obligated for the full 8-week session's tuition. THERE ARE NO REFUNDS.

LATE FEE. A 10% late fee will be applied to all tuition not paid by the 2nd week of the session. Students with outstanding accounts (after the second class) will not be allowed to take class until the account balance has been paid.

NO REFUNDS / REDUCTIONS. No refunds or reductions will be made for classes missed in the session. Classes cancelled by BRT due to hazardous weather conditions or any other reason will be rescheduled.

SERVICE CHARGE. BRT will add a \$30.00 service charge to the student's account for any returned checks. Any additional charges that BRT may incur as the result of a returned check will also be charged to the student's account.
