### **Schedule time frames**

**Rehearsals** will begin the week of January 19, 2025, and can be scheduled for Fridays 5:30-9pm, Saturdays 12:30-6pm. Some Sunday afternoons might be necessary. Main characters, company, and older dancers will also be regularly rehearsing on weeknights.

Two weeks prior to opening night, rehearsal times will change and will extend to include weeknights.

**Starting Saturday, March 7, 2026, all studio rehearsals, and theatre rehearsals are mandatory for each production. These required times may overlap with schools' spring break. Check your calendar!**

**Performances** will be at the KiMo Theatre, March 21 & 22, 2026.

### **Schedule Conflicts and fees**

Please list all family and school commitments that might interfere with rehearsals prior to the 2-week mandatory rehearsals. There is an \$85 costume and rehearsal fee upon casting.

**Two weeks prior to the performance no rehearsals are allowed to be missed, and all theatre rehearsals are mandatory.**
