Payment Policies

<u>TUITION IS NOT REFUNDABLE</u>. Students who miss class or withdraw before the end of the month are still obligated for the full month's tuition. Credit cannot be given for missed classes. Students may make up a missed class by taking a similar class (if it is available) within the same month of the missed class. Please check with your instructor for their recommendation. Students are eligible for pro-rated tuition refund only if they withdraw from classes due to a prolonged illness or severe injury, and if verified by a doctor's certificate.

<u>CANCELLATION</u>. If you intend on withdrawing from class, then you must notify BRT in writing by the 27th of the month or be obligated for the next month's tuition. If written notice has not been received by the 27th of the month, the student will still be considered enrolled and obligated for the following month's tuition. THERE ARE NO REFUNDS.

MONTHLY PAYMENT. Payment is due by the first class of each month. Payment made *prior* to the 1st of each month is eligible for a 10% discount. Monthly tuition is determined by the number of classes offered at each level for the year (August 2022-July 2023), not by the number of classes in any particular month. (Classes occurring in the fifth week of a month will offset those months with fewer classes due to holidays). Any other arrangements must be pre-approved by the Executive Director.

<u>LATE FEE.</u> A 10% late fee will be applied to all tuition not paid by the end of each month. Students with outstanding accounts (more than 45 days) will not be allowed to take class until the account balance has been paid.

NO REFUNDS / REDUCTIONS. No refunds or reductions will be made on the next month's bill for classes missed in the current month. Classes cancelled by BRT due to hazardous weather conditions or any other reason will be rescheduled.

<u>SERVICE CHARGE</u>. BRT will add a \$30.00 service charge to the student's account for any returned checks. Any additional charges that BRT may incur as the result of a returned check will also be charged to the student's account.
